NEF is an umbrella and multi manager Fund managed by Nord Est Asset Management S.A.

## Objectives and investment policy

This equity Fund seeks to invest primarily in stocks issued by companies which operate in emerging markets with a rapid growth, but not yet fully developed. These stocks are dealt on stock exchanges or regulated markets.

The Fund is managed actively in reference to the benchmark MSCI Emerging Markets Net Total Return USD Index (EUR unhedged). The benchmark is not replicated; it merely serves as a starting point for investment decisions. The Investment Manager seeks to outperform the benchmark. The composition of the Fund and its performance may positively or negatively deviate significantly from the benchmark.

The Fund may invest in China A-Shares via the China-Hong Kong Stock Connect Programmes.

Financial techniques and instruments for hedging and/or non hedging purposes may be used.

Income generated by the Fund is reinvested and included in the value of units.

Investors can buy or sell units of the Fund every day which is a bank business day in Luxembourg.

Recommendation: this Fund may not be appropriate for investors who plan to withdraw their money within 7 years.

**Emerging market risk:** A Fund which invests in emerging markets rather than more developed countries may encounter difficulties when buying and selling investments. Emerging markets are also more likely to experience political uncertainty and investments held in these countries may not have the same protection as those held in more developed countries.

**Financial, economic and political risks:** Financial instruments are impacted by various factors, of which, without being exhaustive, the development of the financial market, the economic development of issuers who are themselves affected by the general world economic situation as well as economic and political conditions prevailing in each country.

The charges and commissions are used to cover the Fund's operating costs, including marketing and distribution of units. These charges reduce the potential growth of your investment.


