### What is this product?

### Type

- This product is a class of units of the Sub-Fund and is denominated in EUR. The Fund is an open-ended undertaking for collective investment (Fonds Commun de Placement or "FCP") and qualifies as an Undertaking for Collective Investment in Transferable Securities ("UCITS"), subject to Part I of the Luxembourg law of 17 December 2010 relating to Undertakings for Collective Investment ("Investment Fund Law"), transposing Directive 2009/65/EC related to UCITS.
- As an investment fund, the return of the Sub-Fund depends on the performance of its underlying assets.

### **Objectives**

### Investment objective:

■ The objective of the Sub-Fund is to seek an attractive long-term rate of return, measured in EUR, through investment primarily in equity securities of companies listed on the world's stock exchanges. Investments will be sought primarily in equity securities of companies domiciled in developed countries, but investment may be made in equity securities of companies domiciled in emerging countries. The Sub-Fund has sustainable investment as its objective in compliance with Article 9 of the Sustainable Financial Disclosure Regulation ("SFDR").

#### Investment policy:

- The Sub-Fund is actively managed in reference to the benchmark MSCI ACWI Value Net Total Return Index USD (EUR unhedged) (the "Benchmark"). The Benchmark is not replicated; it merely serves as a reference point. The investment manager seeks to outperform the Benchmark. The composition of the Sub-Fund and its performance may positively or negatively deviate significantly from the Benchmark.
- The Sub-Fund seeks to invest mainly in stocks issued by companies with high quality Environmental, Social and Governance (ESG) profiles. The ESG profile of the company is assessed through both a quantitative analysis based on available international recognised service providers of ESG scores and through a qualitative analysis. The contribution to the achievement of the SDGs is implemented through an internal review of the company practices and its business. The SDG compliance is a prerequisite for the investment. The ESG risk analysis is integrated in the fundamentals and valuation analysis of the company. In particular, the Sub-Fund invests in companies involved in long-term market trends resulting from secular changes in economic and social factors. An exclusion list will further be followed by the investment manager.

- The Sub-Fund will not invest in ABS or MBS. The Sub-Fund may be exposed, on an ancillary basis, to money market instruments to achieve its investment objectives and/or for treasury purposes.
- Financial techniques and instruments for hedging purposes may be used.
- Given the above investment objective and policy and the risk and reward profile of the product, the recommended holding period is 4 vears.

Subscription and Redemption: Investors can buy or sell units of the Sub-Fund every day which is a bank business day in Luxembourg ("Business Dav").

Distribution Policy: Income generated by the Sub-Fund is reinvested and included in the value of units.

### Intended investor

Category R will be available for any kind of investors.

It is suitable for investors who are interested in and expert on the capital market, who wish to invest mainly in equities issued by companies with a high quality ESG profile. The investor must be comfortable with a possible high volatility of the transferable securities in the portfolio, and be able to withstand temporary losses of considerable proportions.

The minimum subscription is EUR 500.

### Term

The Sub-Fund was incorporated for an undefined period. The manufacturer may terminate this product unilaterally under the conditions set forth in the prospectus of the Fund.

### Costs over time

### How long should I hold it and can I take money out early?

### Recommended holding period ("RHP"): 4 years

The RHP has been defined by taking into account the above objectives and risk and reward profile. You should be prepared to stay invested for at least 4 years. However, you can redeem your investment without penalty prior to the end of the RHP, or hold the investment longer. Redemption requests must be received before 2 p.m. Luxembourg time on each Business Day to be dealt with on the basis of the net asset value per unit applicable on that day ("Valuation Day"). Payment for redemptions is expected to be made within 1 week from the Valuation Day. Any cashing-in before the end of the RHP may have a negative consequence on your investment.
