NEF is an umbrella and multi manager Fund managed by Nord Est Asset Management S.A.

Objectives and investment policy

The objective of this equity Fund is to achieve total return.

The Fund is managed actively in reference to the benchmark MSCI USA Net Total Return USD Index (EUR unhedged). The benchmark is not replicated; it merely serves as a starting point for investment decisions. The Investment Manager seeks to outperform the benchmark. The composition of the Fund and its performance may positively or negatively deviate significantly from the benchmark.

The Fund mainly invests in stocks from issuers domiciled in the USA. Investments in stocks issued by companies located outside the USA are permitted.

The Fund has the flexibility to invest in American Depositary Receipts and American Depositary Shares listed on the major U.S. stock exchanges.

From time to time the Fund may employ hedging techniques and hold cash reserves.

Income generated by the Fund is reinvested and included in the value of units.

Investors can buy or sell units of the Fund every day which is a bank business day in Luxembourg.

Recommendation: this Fund may not be appropriate for investors who plan to withdraw their money within 5 to 6 years.

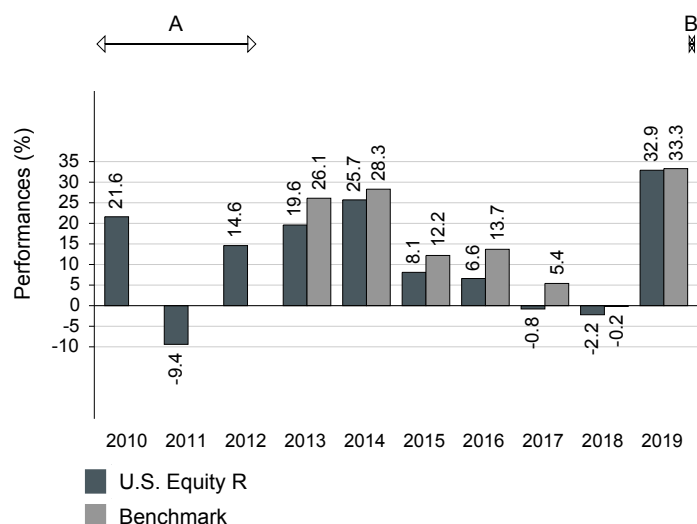
