## What is this product?

#### Туре

- This product is a class of units of the Sub-Fund and is denominated in EUR. The Fund is an open-ended undertaking for collective investment (Fonds Commun de Placement or "FCP") and qualifies as an Undertaking for Collective Investment in Transferable Securities ("UCITS"), subject to Part I of the Luxembourg law of 17 December 2010 relating to Undertakings for Collective Investment ("Investment Fund Law"), transposing Directive 2009/ 65/EC related to UCITS.
- As an investment fund, the return of the Sub-Fund depends on the performance of its underlying assets.

#### **Objectives**

#### Investment objective:

The objective of the Sub-Fund is to achieve capital appreciation, by respecting the Environmental, Social and Governance ("ESG") principles on medium/long term, through an active allocation of the risk mainly in bonds and equities. The Sub-Fund promotes, amongst others, some ESG characteristics in compliance with Article 8 of the Sustainable Financial Disclosure Regulation ("SFDR") but does not have sustainable investment as its objective.

## Investment policy:

- The Sub-Fund will, based on a methodology that includes a variety of ESG criteria, like reducing the investments to the MSCI ESG World Index, considering the investment manager's in-house research and/or third party ESG scoring, apply an ESG promotion approach. An exclusion list will further be followed by the investment manager.
- The Sub-Fund is actively managed in reference to the composite benchmark: 15% MSCI World Net Total Return EUR Index (EUR unhedged), 20% MSCI EMU Net Total Return EUR Index (EUR unhedged), 15% ICE BofAML Euro Corporate Index (EUR unhedged), 40% ICE BofA Global Government Excluding Japan Index (EUR unhedged), 10% ICE BofAML Euro Treasury Bill (EUR unhedged) (the "Benchmark"). For the construction of the portfolio, the Benchmark serves as reference in terms of overall exposure to risk factors including country, credit, interest rate, currency and sector allocation. Amplitude of deviations from the Benchmark varies depending on the degree of conviction of the investment manager.
- The Sub-Fund invests in securities issued by: (i) OECD member countries and countries that launched enhanced engagement with the OECD, (ii) Supranational organizations and entities with investment grade (IG). The Sub-Fund may invest in: (i) Equities, or other funds investing in equities: from 25% up to 45%, (ii) Bonds, or open-ended UCIs/UCITS investing in fixed income instruments: from 40% up to 75%, (iii) Corporate bonds with credit rating lower than IG, or open-ended UCIs/UCITS investing in corporate bonds with credit rating lower than IG: up to 35%.
- The Sub-Fund may also invest in MMI (money market instruments) or in other funds investing in MMI in order to achieve its investment objectives, for treasury purposes and/or in case of unfavourable market conditions. The

Sub-Fund may also invest in financial derivative instruments for hedging purpose, for efficient portfolio management and investment.

Given the above investment objective and policy and the risk and reward profile of the product, the recommended holding period is 3 years.

Subscription and Redemption: Investors can buy or sell units of the Sub-Fund every day which is a bank business day in Luxembourg ("Business Day"). Distribution Policy: Income generated by the Sub-Fund is reinvested and included in the value of units.

#### Intended investor

Category I will be available for a) "professional clients" as defined by Annex II, section 1 of Directive 2014/65/EU of the European Parliament and of the Council of 15 May 2014 ("MIFID II"), even when acting on behalf of their customers in the provision of services and investment activities (e.g. portfolio management); b) the representative associations of the entities under point a); c) foundations; d) public bodies; e) public administrations; f) social security institutions; g) holding companies (i.e. companies that own the assets of other subsidiaries and their sole function is to carry out technical-financial coordination activities of the subsidiaries and do not produce nor exchange any goods and / or services).

It is suitable for a type of investor who is interested in and expert on the capital market, who wishes to invest in a mixed basket, mainly composed by bonds and equities issued by companies with a high quality ESG profile. Investors must consider the possibility of temporary losses of medium importance, which are also a consequence of exchange rate fluctuations.

The minimum subscription is EUR 500.

#### Term

The Sub-Fund was incorporated for an undefined period. The manufacturer may terminate this product unilaterally under the conditions set forth in the prospectus of the Fund.

## What are the risks and what could I get in return? Risks



The risk indicator assumes you keep the product for 3 years.



The actual risk can vary significantly if you cash in at an early stage and you may get back less.

The summary risk indicator is a guide to the level of risk of this product compared to other products. It shows how likely it is that the product will lose money because of movements in the markets or because we, as the management company acting on behalf of the Fund, are not able to pay you. We have classified this product as 3 out of 7, which is a medium-low risk class. This rates the potential losses from future performance at a medium-low level, and poor market conditions are unlikely to impact the capacity of the Sub-Fund to pay you.

This product is in this category because it invests in a range of assets with different levels of risk and its simulated and/or realised return has experienced a medium-low level rises and falls historically.

Not all risks affecting the Sub-Fund are adequately captured by the summary risk indicator.

This rating does not take into account other risk factors which should be considered before investing, these include: financial, economic and political risks, credit risk, currency risk, use of derivative instruments and interest rate risk.

### What happens if Nord Est Asset Management S.A. is unable to pay out?

### What are the costs?

#### Costs over time

The tables show the amounts that are taken from your investment to cover different types of costs. These amounts depend on how much you invest and how long you hold the product. We have assumed (i) in the first year you would get back the amount that you invested (0% annual return). For the other holding periods we have assumed the product performs as shown in the moderate scenario and (ii)  $\in$  10,000 is invested.

## How long should I hold it and can I take money out early?

#### Recommended holding period ("RHP"): 3 years

The RHP has been defined by taking into account the above objectives and risk and reward profile. You should be prepared to stay invested for at least 3 years. However, you can redeem your investment without penalty prior to the end of the RHP, or hold the investment longer. Redemption requests must be received before 2 p.m. Luxembourg time on each Business Day to be dealt with on the basis of the net asset value per unit applicable on that day ("Valuation Day"). Payment for redemptions is expected to be made within 1 week from the Valuation Day. Any cashing-in before the end of the RHP may have a negative consequence on your investment.
